FORMAL BUSINESS OF THE COUNCIL OF GOVERNORS

CoG 93/15 Chair's and Non-Executive Directors' Terms and Conditions

Eric Jarvis presented the paper, which explained the rationale for a proposed minor change to the Chair's and Non-Executive Directors' Terms and Conditions. The contents were noted by the Council of Governors.

The proposed change was to add the word "local" into paragraph 2.3.8, to state, "...you are or become a member of the Board of Directors of any other **local** NHS Body."

The Council of Governors agreed to amend the Chair's and Non-Executive Directors' Terms and Conditions as proposed.

FORMAL BUSINESS OF THE COUNCIL OF GOVERNORS AND BOARD OF DIRECTORS

Cog Proposed change to the Trust Constitution

& Eric Jarvis presented the paper, which explained the rationale for a proposed change to the Trust Constitution, which may be of benefit in the forthcoming re-run of elections commencing in January 2016, where there are four Carer Governor vacancies. The contents were noted by the Council of Governors.

The proposal was to change 4 years to 6 years in paragraph 9.2 as follows:

- 9.1 An individual, who has, within the period specified below, attended any of the trust's premises as a service user or, as the carer of a service user may become a member of the trust.
- 9.2 The period referred to above shall be the period of **6** years immediately preceding the date of an application by the service user or carer of a service user to become a member of the trust.

The Council of Governors and Board of Directors agreed to amend the Trust Constitution as proposed.
