## Key Points to Note:

- 1. The 15-16 Quality Account will be finalised in May 2016, including progress against this year's quality priorities along with the final agreed quality priorities for 2016-17. The Quality Account production timetable is attached overleaf as Appendix 1.
- 2. The engagement process for determining the 16-17 quality priorities has commenced, comprising:
  - An online survey available on both the internet and intranet until 17.01.16 (NB as at 11.01.16 approximately 80 responses had been received).
  - Two quality priority workshops have also taken place with over 60 attendees, representing all stakeholder groups.
