I have been using annual leave/toil and occasional unpaid leave to pursue this. It is high on the agenda for our department and also for other occupational therapists within the trust to receive training in the PRPP assessment. I am conscious that we are the only UK based PRPP instructors and that I would gain financially should any of the occupational therapists from this trust attend PRPP training. The only alternative is to invite the PRPP developers to hold the training, however they are travelling in from Australia which is very costly.
